In the contract with the city of Austin to ChannelAustin the nonprofit will reimburse the city for all and any legal expenses arising from this contract please furnish copies of invoices checks and receive to the city from the nonprofit please furnish all documentation concerning reimbursement for 2007 2008 and 2009.

Please furnish complete personnel file for Rondell Hawkins any letters accommodations or criticism her original application for her job her resume when submitted to the position she currently holds. Any and all documents that would justify her existence in holding this job.

Please furnish all communications from Time Warner to the city of Austin concerning payment of the \$1.8 million owed to channelAustin that took the city almost 2 ½ years to collect.
